



INFORMATION NEEDED TO COMPLETE YOUR FAFSA FOR THE 2018/2019 ACADEMIC YEAR

- PARENT'S SOCIAL SECURITY NUMBER AND BIRTHDATE
- PARENT'S 2016 FEDERAL INCOME TAX RETURN (If an amended return was filed, please bring the original return **AND** the amended return)
- IF CHILD SUPPORT IS RECEIVED **OR** PAID PLEASE BRING DOCUMENTATION OF THE AMOUNT
- IF THE PARENT DOES NOT FILE INCOME TAXES PLEASE BRING THE SOCIAL SECURITY OR DISABILITY STATEMENT FOR 2016 (if the parent does not receive disability/SSI, you will need a statement of how the parent supports themselves/family)
- IF YOU, THE STUDENT, FILED AN INCOME TAX RETURN FOR 2016, PLEASE BRING YOUR 2016 FEDERAL RETURN AS WELL
- STUDENT'S DRIVERS LICENSE (if applicable)
- PARENT'S MONTH AND YEAR OF MARRIAGE, DIVORCE, SEPERATION, WIDOWED
(If the parent has never married that is o.k.)

** **ALL** STUDENTS' FAFSA's REQUIRE A PARENT'S ELECTRONIC SIGNATURE UNLESS THEY ARE EITHER: (1) 24 yrs. old (2) married (3) have a child that receives at least 50% of their support from the student (4) an "independent student". (Ask your counselor what "independent student" means if you do not know) THIS MEANS AN FSA ID HAS TO BE CREATED FOR THE PARENT AS WELL AS THE STUDENT. IN ORDER FOR US TO CREATE AN ID, WE WILL NEED **ONE** PARENT'S: (1) City of birth (2) Their mother's maiden name. IF NEITHER OF YOUR PARENTS ARE CITIZENS NOR LEGAL RESIDENTS, A SIGNATURE PAGE CAN BE PRINTED AND SIGNED IN PLACE OF CREATING AN FSA ID. **PLEASE ACQUIRE THIS INFORMATION BEFORE YOU COME**

** IF YOU CHOOSE TO ALLOW US TO HELP YOU COMPLETE YOUR FAFSA AT THE SCHOOL AND YOUR PARENTS ARE UNABLE TO COME WITH YOU, YOU MAY BRING THE REQUIRED INFORMATION YOURSELF.

** IF YOU PLAN TO ATTEND THE SUMMER SEMESTER OF 2018, YOU/WE WILL NEED TO FILL OUT THE 17/18 FAFSA. YOU WILL NEED ALL OF THE ABOVE INFORMATION EXCEPT 2015 TAXES WILL BE USED. IF THIS IS THE CASE, BOTH THE 17/18 AND 18/19 FAFSA CAN BE FILED AT THE SAME TIME.

** IF NEITHER YOU NOR YOUR PARENT ARE ABLE TO ATTEND THE SCHEDULED MEETING TO FILE YOUR FAFSA, WE WILL BE GLAD TO ASSIST YOU/THEM IN OUR CULLMAN OFFICE. IF YOU NEED DIRECTIONS PLEASE FEEL FREE TO CONTACT OUR OFFICE.
